FULL MEMBERS \$200.00

Subscribing Full-Playing Members.

PLURAL MEMBERS \$200.00

A Full-Playing Member of more than one Club.

LIMITED MEMBERS \$150.00

This membership class is designed to cater for those members who because of age, physical ability, health – or other reasons are restricted in the amount of bowls they are able to play. Generally they wish to retain Club membership but are unable to commit themselves to any more than occasional "Club Day" type play. Written application to the Secretary is required.

FIRST YEAR MEMBERS \$55.00

Players who are members of a bowling Club for the first time. A reduced subscription is applicable for this first year of membership. These members have full playing rights.

ASSOCIATE MEMBERS \$55.00

Associate members are already full playing members of another affiliated bowls club. They have playing rights similar to those of Limited Members. They may take part in social and non-championship aspects of this Club's programme.

STUDENT MEMBERS \$55.00

Students who are joining the Club, as an enrolled student, in a school or tertiary institution.

SOCIAL MEMBERS \$10.00

Social Members are NON-BOWLING members. They are able to take part in various social and pavilion activities.
